1. The Yearly fee for occupation of stall is **Rs 6,000/-**-which can either be paid in full or in 2 equal instalments of Rs 3,000/-.
2. The successful applicant will also have to pay the appropriate Trade Fee and enter into a contract for a period of 3 years with the Council.

3. Eligibility

Any person interested in occupying a stall should satisfy the following criteria:

- i. Be a resident of *The District Council Area of Grand Port And The District Council of Savanne*.
- ii. Have reached his/her 18th birthday at time of application.
- iii. Applicant should not be a civil servant.
- iv. Not already be holder of any stall, shop or other place inside a market or fair within the District Council of Grand Port or any other local authority.
- v. Undertakes to personally occupy the stall.
- vi. Each applicant will be allotted only one stall.
- vii. Allocation of stalls would be made by drawing of lots on a date, time and place, fixed by the Council.
- viii. Only applicants satisfying the eligibility criteria will be invited to attend the drawing of lots.
- ix. At time of application, applicants should submit a copy of their National Identity Card, proof of address (CEB, CWA or MT bill for the last three months) and a recent Unemployment Card from Ministry of Labour, Industrial Relations and Employment.
- x. **Successful applicants will be required to produce the original of all the above mention documents prior to participating in the drawing of lots exercise.**

4. Mode of Application

For further details and application forms, interested persons should call at the Public Health Department, of The District Council of Grand Port, Rose Belle or may download the application form from Council's website <http://dcgp.mu>.

5. Submission of Applications

Applications forms in plain sealed envelopes should be addressed to the Chief Executive, The District Council of Grand Port, Royal Road Rose Belle on or before **Thursday 27th July 2017 at 13.00 hrs at latest.**

The envelope should indicate clearly the Expression of Interest for the occupation of vacant stalls.

Applications received after the specified closing date and time will not be accepted and considered.

Incomplete, inadequate or inaccurate filling of the application form will lead to elimination from the exercise.

Applications not made on the prescribed form will be rejected.

6. Reservation

The Council reserves the right to accept or reject any interest expressed and annul the whole Expression of Interest exercise without thereby incurring any liability whatsoever to those persons who have expressed an interest or to inform them of the grounds thereof.
