 4. Electronic bidding shall not be permitted. Bids received after the prescribed date and time will not be considered.

5. Bids will be opened physically in the presence of Bidders /Bidders' Representatives who choose to attend ***in the Council Room, The District Council of Grand Port, Royal Road, Rose Belle on the same day as from 13.15 hours (local time).***
6. For any query, Bidder shall address the Chief Executive, The District Council of Grand Port, Royal Road, Rose Belle.

 - (i) to accept or reject any bid and
 - (ii) to annul the bidding process and reject all bids at any time prior to award of contract as per the provision of Section 39(i) of the Public Procurement Act 2006.
