The District Council of Grand Port is pleased to invite bids from qualified and eligible bidders for procurement of A & B as per requirement contained in the Bidding document.

Participation is limited to Citizens of Mauritius, or entities incorporated in Mauritius. Joint Ventures should be among entities incorporated in Mauritius.

Bidders shall be registered with the Ministry of Local Government and Disaster Risk Management as Scavenging Contractor.

The procurement is being conducted through Open National Bidding procedures according to the provisions of the Mauritius Public Procurement Act 2006 as amended.

**Bids must be submitted online on the e-Procurement System on Wednesday 17 April 2024 up to 13.30 hours (Mauritian Time) at latest for procurement of both A & B.**

**Bidders who have submitted bids online by the closing date and time shall decrypt and re-encrypt their bids on Wednesday 17 April 2024 as from 16.01 hours (Mauritian Time) till Thursday 18 April 2024 at 10.30 hours (Mauritian Time) for procurement of both A & B.**

**Bids shall be opened online on the e-Procurement System on Thursday 18 April 2024 as from 10.31 hours up to 16:00 hours at the address mentioned below for procurement of both A & B.**
